Worship and Music

Baptisms, Recent and Upcoming

Marek Boytim—Marek was baptized on Easter Sunday, April 20, along with his family being received into membership (as discussed back at the April meeting).

Christopher Nowak—Christopher, son of Mike, grandson of Ellen and Dave Nowak, and great-grandson of Marie Sheets, was baptized on April 27. Our hope had been for him to be baptized here where Marie could be present, but her sudden turn in health that led to hospice and then to her death meant that she had died just days before his baptism.

Lakai Stout—As mentioned at our last meeting, Lakai's mother is Alyssa, the granddaughter of our Cherryl Stout, and Alyssa's other children were baptized here as well. This will be on May 18 at the 8:00am service.

- <u>Shift to One Service for Summer</u>—We'll return to the summer 9:00am service time on May 25 (Memorial Day weekend) and that will run through Blue Jeans Sunday on Sept. 7, after which we'll return to 8:00am and 10:00am.
- <u>Confirmation Date</u>—Our Confirmands will affirm their baptism at the 9:00am service on June 1; we'll have five confirmed this year, all from Community of Christ.
- Pentecost Sunday—Pentecost is June 8.
- Recognition of Graduates—We will end up having recognition of our grads from the Class of 2025 during the milestones time of two Sundays, May 25 and June 1, to have a chance to recognize them all (there's no date that works for everyone), but we'll present the gift Bibles as we did last year, with special verses underlined and highlighted by members of the congregation.

I'll be following up with them for pre-marital guidance and wedding planning, primarily through video/Zoom meetings.

Emma Fifer and Fiancee—Emma, daughter of our Amy Fifer and granddaughter of Eunice Kronberg, has asked if we can host her wedding on Friday, Aug. 7, 2026 and for me to officiate. That is now on the church calendar and I'll be meeting with them in the coming weeks to begin plans for *next* summer.

Christian Education and Youth

 Adult Class (Sundays)—Our current series, Imaging the Word, will conclude this month, and we'll be again asking participants if they would like to continue with Adult Forum on Sundays after the 9:00am service through the summer like last year, and if so, continue.

- <u>Sunday School for Children and Youth</u>—We will end Sunday School for this year with May 18 and then work over the summer for our plans for the new school year.
- Collaboration with UMC/ELCA Neighboring Congregations for Anthony Wayne Youth Group—
 We are planning to host a car wash at Community of Christ on June 7 from 9:30-11:30am to
 benefit Neighborhood Bridges and will provide pizza lunch for our youth who participate at
 the end. We are also looking at a back-to-school event, hopefully hosted here at Community
 of Christ, on August 24, to build on the success of last year's event like this.
- <u>Confirmation Program</u>—As mentioned, we will be concluding our classes for this school year soon, but here are some details to know:
 Students Being Confirmed: Mark Bond, Andrew Carman, Ava Davis, James Fifer, Trevor Nye Dinner: Our Confirmation dinner will be held here at Community of Christ on the evening of May 30 at 6:00pm for confirmands and their families.
 Confirmation Day: June 1 at the 9:00am service.
- <u>Thursday Afternoon Bible Study</u>—Our current series on Judges will run through May and then we'll begin a new series in the summer.
- <u>Vicar Natalie's Summer Spirituality Series</u>: Vicar Natalie's plan for a summer-long series of Thursday evening events is now public with sign-ups, a schedule, and details firmed up. We invite all, both from within the congregation and in the wider community, to join us for these weekly gatherings.
- <u>Joint Children Youth Family Ministry Coordinator with Providence</u>—We have had several
 productive interviews since our April council meeting, and are looking at a third-round
 interview for at least one and possibly two candidates. If those lead to a recommendation
 for a single candidate we'll be bringing all the details to each congregation's council to be
 aware and in the loop before a candidate would be hired.

Concert Committee

• Swingmania, Charity Auction, and Burger Bar Night—While much of this event was successful, the concert part of the evening did not break even on its own between ticket sales and the cost of the band. The charitable auction was well-received and worked well, and the meal was designed to at least break even between costs and ticket prices. We did have some additional after-the-event donations to help defray the costs of the concert itself, but we'll need to revise how we conduct future ticketed concert events, as well as promoting/advertising, in order to do a better job of at least breaking even for concerts whose purpose is just to offer good cultural experiences, and to raise funds for those concerts intended to be a benefit for our Building Fund and Lutheran Disaster Relief.

Administrative Matters

Plans for Office Coverage When Michelle is On Vacation (Summer 2025 especially)—
Especially during the summer when Michelle is on vacation around her daughter's wedding, we'll need clear plans for what we expect for office coverage. We had several names from time and talent as people who could help to answer phones and be present in the office at least for part of the day during those days. Michelle is going to reach out to those people and inquire about possible availability to cover the days of vacation so we know what and who we have to work with, and we'll probably plan to limit their help to answering phones, taking messages, and being an in-person reception presence, but to just hold off with the other work Michelle does during that week (financial secretary, newsletter, bulletin, etc.—some of those can be done ahead in advance, and some can be picked up with after her return). I'll be glad to be a back-up for checking phone messages and we can have an out-of-office reply to emails directing people to reach out to me or the church by phone for urgent matters or to wait until Michelle's return for other email correspondence.
