PLC & CofC Youth Group

- <u>Meetings</u> We've held two youth group gatherings to date, with 12 youth attending the first and 7 at the second. Both meetings included plenty of fun, thoughtful discussion about our goals, and reflection on what it means to live as a community of Christians.
- Ongoing By majority request of the youths, we will now be meeting weekly on Sunday nights alternating between CofC and Providence.

 - November 9th we will be baking cookies for Salem to give out with their Tuesday community meal.

Worship

 <u>CYF Engagement</u> - Received positive feedback from the worship committee on worship bingo as an intergenerational tool to help people listen attentively and work together. We will be piloting a similar idea in the near future called "Praise Prompts" wherein when something is said in service, the congregation is invited to make a related hand signal that ties into the message i.e. making a small heart with their hands etc.

 Work on updating the Child Protection Policy is ongoing. Further updates will be shared at the November Council meeting.

Pastor's Report to Council—October 2025

Worship and Music

- <u>Reception of New Members</u>—On November 9, we plan to receive three new members into the congregation by transfer from other congregations: Julie Paulsen, Kevin Steinman, and Curtis Rhoten (fiancé of Emma Fifer, who will be married here in summer 2026; family of Amy Fifer, Eunice Kronberg, etc.)
- <u>Upcoming Baptisms</u>—We'll have the baptism of Madilyn McCann (great-granddaughter of our Bea Ludwig) on Sunday, October 19, and the baptism of Landon Stewart (son of Makayla and Mitchell) on Sunday, October 26. I have either met or scheduled meetings with those families in preparation for those baptisms, and the baptismal blankets and embroidered napkins/cloths are ready as well. (Both will be at the 10:00am services respectively.)
- <u>All Saints</u>—We'll again have our usual reading of names and display of photos on a table in the back of the worship space for All Saints' Sunday, which will be Nov. 2, 2025.

Christian Education and Youth

- Confirmation Program In Full Swing—Our students from Community of Christ this year are (second year) Evan Ackerman, Anna Bond, Jillian Dewitz, and Jett Jenkins, and (first year) Josie Hartbarger, Graci Pollock, Hope Kimball, Evangeline Boytim, and Natalie Meyer (members at Zion, too, who sometimes attend here); there are also several continuing and new students from Zion. I've also met initially with Joan Bierly to make plans for having the quilters make confirmation stoles for our 2026 confirmands to get that in motion.
- <u>First Communion Instruction</u>—Valerie Hartbarger has begun first communion instruction, and we'll be looking for a date coming up soon to include that milestone of faith in worship after we have completed our preparation and time.
- <u>Labyrinth Outing</u>—Vicar Natalie and I are offering to lead a group to go to the outdoor Labyrinth in Perrysburg on the late afternoon of Oct. 26 for any who want to go and experience it, and then invite those who want to join for dinner after and have conversation somewhere about the experience.
- Adult Class (Sundays)—Our current series for the fall, entitled, "Who Is My Neighbor?" has
 been featuring voices and perspectives from people in the wider community, including Calla
 Gilson from the Synod office, Destinee Chapa from Project LIFT/Bridge of Hope (migrant
 workers), and Pastor Mike Hanck. This will conclude on Oct. 19 and the next series will be led
 and organized by Vicar Natalie.
- <u>Thursday Afternoon Bible Study</u>—Vicar Natalie and I will conclude our series called "Faithful Rebels: Biblical Stories of Devout Defiance" later in October, and we'll proceed with another series after that.

Social Action

- Projects for Salem Lutheran Meal Ministry and Tree-Planting—We were able to give more than \$750.00 to Pastor Hanck in worship on Oct. 5 for the weekly meal program thanks to donations in connection with our "Abundance is meant to be shared" stickers, and we were able to raise more than \$1,000.00 between tote bags and other outright donations for the trees to be planted at Salem's arboretum on the afternoon of Sunday, October 12.
- <u>School Supply Kits for Lutheran World Relief</u>—Our collection of more than 70 kits was blessed in worship on Sunday, October 5, and Carrie Tuohy will take them to the local collection point later in October (likely on a day before our October council meeting).
